## Sub: Procedure for removal of publications from defunct status-reg.

It was observed that many publications had not filed their Annual Statements for several years (three or more) in the prescribed form as per Section 19 D of the Press and Registration of Books Act, 1867. Accordingly, such publications were placed under the defunct list and concerned District Magistrates/Specified Authorities were requested for initiating action under Section 8(B) of the Act vide letters of even no. dtd. 12.11.2021. An advisory to publishers dtd. 17.03.2022 was also issued in this regard. It was also requested that, upon enquiry if such publications were being found to be continuously publishing, the same may be informed to the Press Registrar. For the sake of convenience, a format for Continuity certificate was also provided (Enclosed).

- 2. Since then, a large number of publishers have submitted the continuity certificate duly authenticated by the concerned Magistrate/Specified Authority. These publications have been removed from the defunct list and the status of such publications have been restored after the publishers have paid requisite penalty for non-filing of Annual Statements as per Rule 12 of the Registration of Newspapers (Central) Rules, 1956 and submitted the pending Annual Statements.
- 3. It is once again informed for the convenience of the publishers that, if their publications have been identified as defunct (Check status: <a href="http://rni.nic.in/AllData/AllData.aspx">http://rni.nic.in/AllData/AllData.aspx</a>), the following procedure may be adopted to remove such publications from the list;
  - A) A continuity certificate may be authenticated by the concerned DM/specified authority as per the enclosed format, if publication is in defunct list.
  - B) The above certificate may be got forwarded from the office of DM/Specified Authority either by registered post or through official email ID (NIC/Gov) of the Magistrate to the O/o RNI (Address as above and email ID: registration-rni@gov.in)
  - C) After receipt of the continuity certificate, the Office of RNI will enable the Publisher to pay penalty and submit Annual Statements through the online portal (https://egov.rni.nic.in/)
  - D) For the payment of penalty and submission of Annual Statements, the instructions given in the below link may be followed: <a href="https://egov.rni.nic.in/DocFiles/Online Payment system for paying the penalty to\_RNI.pdf">https://egov.rni.nic.in/DocFiles/Online Payment system for paying the penalty to\_RNI.pdf</a>

E) After the above steps, the defunct status of the publication will be removed.
